Douglass files complaints Simonsen-Lare form team

LOWER TOWNSHIP – Erik Simonsen, who had to give up his Ward 2 council seat in December, is joining with Deputy Mayor Kevin Lare to run for council leadership positions in the November general election.

Simonsen and Lare issued a joint press release on Feb. 17, announcing Simonsen would run for mayor, while Lare would run for reelection. Simonsen said after moving out of the ward disqualified him from serving as a ward councilman, he was interested in running for another council seat.

"I definitely was. I didn't anticipate having to step down, and I guess fuel-

ing the fire was, I had to sit through the first few months of the chaos, the not getting along, nothing getting done," Simonsen said.

Simonsen was referring to ques-tions raised over filling his vacated Ward 2 seat, an appointment to the LTMUA board, and the reappointment of Township Solicitor Mike Donohue. With only four members on council, the governmental body could not agree on the appointments or filling the vacancy on council. Since that time there was also disagreement as to whether the Republican Committee's selection to fill the vacancy, Walt Craig, should have been sworn in at the Jan. 18 council meeting. Council has asked the Cape

LOWER TOWNSHIP – Lower Township Ward 3 Councilman Glenn Douglass filed complaints with the Department of Community Affairs and District 1 Attorney Ethics Review Board alleging conflicts of interest between council members and the township solicitor.

Douglass said he raised the issue about a month or more ago at a township council meeting. He said a citizen had asked whether Councilman Tom Conrad, as a member of the Lower Township Republican Committee and a councilman, had a conflict in voting for Walt Craig to fill the vacant Ward 2 seat. Douglass said he asked Township Solicitor Mike Donohue to

speak on the matter.

"He answered that he basically didn't think it was an issue because (Conrad) abstained from voting at the actual committee meeting," Douglass said.

"Meanwhile the other issue," Douglass said, "is, being that (Conrad) is an elected county committee member, and Mike Donohue the chairperson, whether that was a conflict for (Conrad) to vote on (Donohue's) contract.'

"What was thrown to DCA was, (Conrad) and Walt (Craig) are they capable of voting on the solicitor's contract? That is probably going to be the more conflicting issue," Douglass

South Jersey Gas project is cooking



CAPE MAY POINT The trucks have been out and crews have been working non-stop since gas main installation began in October 2011.

"They should be completed putting in the mains by the end of this month," Mayor Carl Schupp said. "They are about 400 residents interested in natural gas service. Of that number, about 300 turned in applications, and 190 customers have had gas service hooked up.

"We've had a really high level of interest from folks in Cape May Point," Gordon said.

Three-phase sewer project slated for Sept.

WEST CAPE MAY - A three-phase project to improve the water and sewer infrastructure for residents in West Cape May is expected

ough received a funding package that included a grant for \$708,000 and a low interest loan of \$2,305,000 from the Rural Development Water and Environmental Program administered by the United States Department of Agriculture (USDA).

Borough Engineer Ray Roberts said at a Feb. 8 Board of Commissioners meeting that sewer pipes will be installed in areas where ser-vice in presently non-existent. Many of these areas consist of small lots and old septic tanks. He said the project fills in gaps between two ends flowing in opposite direc-tions, and will bring service to properties that use septic tanks, which have started

ect is spread out across sec-tions of Third, Fourth and Fifth Avenues, as well as a portion of State Street. Roberts said the third phase may take place either before or after Memorial Day, weather permitting.

"The idea here is to get this all done without any kind of summer shutdown break, depending on how affective the contractor may be," he said.

Mayor Pam Kaithern said the entire project falls within the approved sewer service area. Roberts asked the board if they agreed with using one contractor to complete the entire project, or divide it into two separate contracts over two construction seasons. Council agreed it would most likely be less expensive to award the bid to one contractor.


