BOROUGH OF WEST CAPE MAY COUNTY OF CAPE MAY STATE OF NEW JERSEY ORDINANCE NO. 613-22 AN ORDINANCE AMENDING SECTION 27-19 OF THE WEST CAPE MAY ZONING CODE PERTAINING TO HISTORIC PRESERVATION

WHEREAS, N.J.S.A. 40:55D-65.1 provides for the designation and regulation of historic sites or historic districts by way of a zoning ordinance; and

WHEREAS, Section 27-19 of the West Cape May Zoning Code governs the preservation of historic structures in the Borough and authorizes the creation of an Historic Preservation Commission and the establishment of an Historic District; and

WHEREAS, Section 27-19.4 of the Code provides for the creation of an Historic District Map that delineates the scope of the Borough's Historic District, together with provisions for the designation of historic districts and structures; and

WHEREAS the Borough's Historic Preservation Commission believes it is in the Borough's best interest to preserve and protect the historical, cultural, and architectural culture of the Borough; and

WHEREAS, the Borough's Historic Preservation Commission has reviewed the current Historic District and has unanimously recommended that the District be expanded in certain areas, and that a particular property be designated as an historic structure; and

WHEREAS, attached to this Ordinance is a map showing the proposed expansion of the Historic District and added historic structure, together with a list, by block and lot number, of the affected properties; and

WHEREAS, having thoroughly reviewed the matter, the West Cape May Borough Commission believes it in the Borough's best interest to adopt the recommendations of the Historic Preservation Commission and expand the Borough's Historic District accordingly.

NOW, THEREFORE, BE IT ORDAINED by the Borough Commission of the Borough of West Cape May that Section 27-19.4 of the West Cape May Code be amended as follows:

Section 1. The Borough hereby adopts the attached map as the Historic District of the Borough of West Cape May, and Section 27-19.4(d) of the West Cape May Borough Code is amended so that the Borough's Zoning Map, including delineation of this expanded Historic District, is incorporated into the Section.

Section 2. After introduction and before final adoption, this Ordinance shall be referred to the West Cape May Consolidated Land Use Board for a master plan consistency review pursuant to N.J.S.A. 40:55D-26(a) and -64.

Section 3. Contemporaneously with final adoption, and pursuant to N.J.S.A. 40:55D-65.1, the Borough Commission will adopt a Resolution setting forth its reasons for including these properties in the Historic District.

Section 4. Repealer. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed to the extent of that conflict.

Section 5. Severability. Should any portion of this ordinance be declared unconstitutional or invalid, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are declared to be severable.

Section 6. Effective Date. This ordinance shall take effect 20 days after passage and publication, according to law.

The foregoing Ordinance was introduced at a Regular Meeting of the Board of Commissioners of the Borough of West Cape May held on April 27, 2022, when it was read for the first time and then ordered to be published according to law.

This Ordinance will be further considered for final passage, after public hearing, by the Board of Commissioners of the Borough of West Cape May at a meeting to be held at Borough Hall, 732 Broadway, West Cape May, New Jersey on May 25, 2022 at 7:00pm or as soon thereafter as possible, at which time and place, all persons interested will be given an opportunity to be heard concerning such ordinance.
