AN ORDINANCE AMENDING SECTION XVIIII OF THE BOROUGH CODE REGARDING SOLID WASTE MANAGEMENT
This ordinance amends the Borough code regarding solid waste management incorporating changes to the types of recycling materials that will be accepted for processing by the Cape May County Municipal Utilities Authority. The ordinance also clarifies the code confirming the responsibility of commercial and industrial property owners for collection of solid waste, the responsibility of residents to provide their own receptacles, and that residential bulk trash is collected twice each year.
