it's due diligence.' Powell said anytime there are floods there are health issues and people might have to contact their Health Department, especially when they are dealing with septic tanks. The Cape May County Health Department is testing people's wells for contamination from flooding.

Powell said there is no closing date for the DRC, and the length of FEMA's stay in Cape May County is driven by the need.

have registered with FEMA. "The application is a gateway to further federal assistance," he said.

Powell said being denied an

SBA loan is a necessary step in qualifying for other federal assistance, so people should fill out the application.

Applicants must provide proof of residence and the application process will include an on-site inspection.

"They are FEMA contractors. All FEMA personnel have ID badges. If they don't have the badge they are not with FEMA," Powell said. Powell said when communi-

ty relations people from FEMA knock on someone's door it is to give information, not to ask for it. He said no FEMA personnel would ask people for Social Security numbers (at the home) or bank account numbers.

Lt. Lynn Frame from the Cape May County Prosecutor's Office said whenever money is being disbursed quickly there is a potential for fraud. She said any fraud victims should contact the prosecutor's office and it will prosecute. And if they find the fraud is of an organized nature it's possible the FBI might get involved in the investigation.

When applying, applicants will have to provide an address and phone number where they can be reached, their Social Security number, a current mailing address, the date the damage occurred, the address of the affected property, a brief description of the damages. Insurance information, and the family's gross income.

although the bids were rejected, the city has gotten some information to work with in the rebidding process.

"We're going through another review for value engineering, we made a couple of adjustments in designs and looked at the bid specifications for clarity. We thought a few items were not easily understood and we tried to clarify them to eliminate the possibility the bidders would have to bid higher because they were uncertain what was being asked for,' MacLeod said.

MacLeod said "value engimeans neering" through the design and engineering to see if certain features could be managed better and create a cost savings, perhaps made with different materials

He said it is still the city's vision and plan for a geothermal energy system and to have a solar array on top of the structure.

"We outlined many months ago we would like to complete the solar project through a power purchase agreement. We would have a separate vendor or contractor do the installation of the solar panels, and the benefit to the owner of the property is to have reduced kilowatt prices," MacLeod said.

Normally, the power purchase agreement lasts 15 years, when the solar panels become the property of the owner of the building. MacLeod said the city would

continue to look at the wind

turbines also proposed for Convention Hall. Asked about the possibility

of scaling back the project, MacLeod said right now the city is planning to rebid the project based on the current, proposed size. He said the city has gone through the value engineering process twice, but the building basically remains the same size.

Asked if scaling back the project, while perhaps cutting costs, would further delay the project, MacLeod said, "Every day or week that goes by makes it more and more difficult to meet our deadline. When we went through the initial bidding process we were very tight in our timeline for opening Memorial Day Weekend

MacLeod said the city is without a Convention Hall and the goal is to have a building to allow the city to bring back certain activities to the beachfront.

He said residents and visitors were used to the functions and activities, which are lacking without Convention

"The idea of getting the project off the ground and having the facility built - that's the bottom line," he said.

The city will advertise for new bids on Friday, April 30. MacLeod said the ad would go out to the local daily paper because of the time element and to an online trade site most of the major contractors
