ORDINANCE NO. 580-20
AN ORDINANCE AMENDING SECTION 27 OF THE BOROUGH CODE REGARDING BUILDING EAVES AND GUTTERS AND

WHEREAS, the Borough of West Cape May is committed to preserving the unique character of the Borough and encouraging responsible development that preserves light, air, and open space in the community and promotes the public health, safety, and general welfare of its residents; and

WHEREAS, the Borough Commission of the Borough of West Cape May believes it is in the best interest of the Borough to amend Section 27 of the Borough Code to provide specific regulation of building eaves in relation to the setback requirements and require the installation of gutters and downspouts in connection with new

development; and NOW, THEREFORE, BE IT ORDAINED by the Borough Commission of the Borough of West Cape May as follows:

Section 1. Section 27-6 of the Borough Code shall be amended as follows, with all strikethroughs indicating deleted portions and all bold and underlined portions indicating additions:

27-6 DEFINITIONS Setback line shall mean a line drawn parallel with a street line or lot line and drawn through the point of a building nearest to a street line or lot line. Building eaves may extend no further than fifteen (15) inches beyond the required setback line, otherwise variance relief shall be required. This building eave exception shall not apply in any instance where its application would cause the building eave to encroach beyond a property line or into a public Right of Way

Section 2. Section 27-27 of the Borough Code entitled "Supplemental Regulations" shall be amended to include the following new section: 27-27.4 Gutters and Downspouts.

(a) All new construction or reconstruction, conversion, alteration or

enlargement of any building, portion of any building, or other structure shall be required to be outfitted with gutters and downspouts for purposes of directing storm water away from adjacent properties and towards on-site storm water facilities, or, toward the street. If impossible to drain directly to the street, it shall be directed to a system of interior yard drainage approved by the Municipal Engineer.

(b) Any development as defined in Section 27-6 that requires approval from the Borough of West Cape May Combined Planning and Zoning Board, and impacts drainage or stormwater runoff, may be conditioned on the installation of gutters and downspouts, and any other related system recommended by the Municipal Engineer to direct or control stormwater runoff from the property in accordance with the Borough Code.

Section 3. Repealer. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed to the extent of that conflict. Section 4.Severablility. Should any portion of this ordinance be declared unconstitutional or invalid, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are declared to be severable.

Section 5. Effective Date. This ordinance shall take effect 20 days after passage and publication, according to law.
