After 35 years, Civic Affairs director set to retire

CAPE MAY - Picture any annual event, holiday ceremony or recreational activity the City of Cape May has to offer and odds are its inception will lead back to Terry

Brown is the Director of the Civic Affairs Department and as of March 1, 2012, he will have officially retired after 35 years and five months of service. He said working with Cape May Civic Affairs is the only job he has had since graduating college. Brown originally wanted to use his Parks and Recreation

degree from Shippensburg University (Pa.) to become a park ranger. While he was attending school, a close friend joined the U.S. Coast Guard and told him how incredible Cape May was.

"He told me it was the greatest place in the world,"

Brown said. Brown and other friends from college began spending their spring breaks and summer vacations in the area and eventually he was hooked because of the plentiful jobs at the time and the scenery. Being from Grove City, Pa., he had never seen the ocean before and was instantly cap-

tivated by it.

"Once you fall in love with the ocean and the shore, it's hard to get it out of your system," he said.

After college graduation, his father, Clint, wanted him to work for the family insurance agency but Brown quickly realized he didn't like it and came back to Cape May in late 1975. At the time, Robert Smeltzer, who became a close friend of Brown, was the director and getting the Department of Civic Affairs up and running. Smeltzer modeled the organization after the YMCA and asked Brown if he wanted to get

Public sees design for Lafayette Street park

CAPE MAY - The city's final design for the 38-acre Lafayette Street Open Space Project was revealed last Wednesday during a press conference at City Hall.

Mayor Edward Mahaney said it was the conceptual design of the project that clean soil. Land acquisition is anticipated to cost more than \$3 million.

Temple University graduate and Philadelphia University grad student Julia Dougherty, one of the designers for the Lafayette project, attended the meeting to give the public a better idea of how the area would be used. Dougherty earned a degree

led to the \$450,000 Green Acres state grant, which will be used for land acquisition. Properties the city still needs to acquire are privately owned lots on St. Johns Street and the former Vance's Bar property on Lafayette. Jersey Central Power and Light (JCP&L) is also expected to donate land to the city from one of its previous locations used as a coal gasification plant. JCP&L will be excavating that area of contaminated from Temple in landscaping and architecture, and put it to use when envisioning this project, mapping it out two years ago.

Dougherty said she and her fellow teammates responsible for designing the project, surveyed Cape May residents at public meetings prior to drawing the plans and asked what they would like to see in the project. 'We asked the people of

ATLANTIC CITY – Fishermen's Energy of Cape May announced last week they were one step closer in building what could be the first offshore wind farm in the nation, which will be located nearest to Atlantic City.
