Mahaney said the city's obligation of the purchase price is \$4.4 million with \$2.2 million of that amount is being funded through a state grant. Another \$2 million is coming from Cape May County open space funding the first open space grant the City of Cape May has received, although taxpayers pay into the county open space fund. The remaining \$200,000 will come out of the city's own open space fund.

"When the original proposal was put in for Green Acres money, we were told if we set up a one-cent tax for open space it would be doubled by Green Acres. We now have \$1 million in that account, so we will take out \$200,000 and it will cost the taxpayers nothing," Mahaney said.

Mahaney said if the area had been developed according to the original application


the city would have had to add a police and fire substation, besides the new water tower. Now the approximately 78 acres will become the Point Wildlife Sewell Sanctuary, a passive recre-ation site and wildlife habitat. The property is already a well-known stopover for migratory birds. According to information provided by DEP attorneys, the Sewell Tract is the largest privately owned property within walking distance of the ocean.

The DEP rejected permit applications to develop the property with 366 residential units and the developer filed suit against the state claiming the state was "taking" the owner's property by denying the permits. Litigation proceeded through the appellate level with no resolution until the recently mediated agreement, presided over by the late New Jersey Supreme Court Justice Daniel O'Hern.

Mahaney said a memorial plaque signifying O'Hern's role in the process would be erected at the site.

Mahaney said the final realization of the process would take several years. According to a DEP press release, the settlement announced Tuesday is subject to "applicable regulations, including the submission of complete permit applications by the developer, and a public review and comment period, and review and approval by the U.S. Army Corps of

Engineers. Freeholder Director Daniel Beyel told the city once the settlement is finalized the county would write a check to the city for \$2 million. The city would begin work on trails, paths and observation decks for the site, which would be managed by a thirdparty agency.


