More data sought on Historic District expansion

Planning Board wants map, justification for homes being included

CAPE MAY — As many as 189 properties are being considered for inclusion in Cape May's Historic District.

At a Nov. 26 meeting, the Planning Board discussed a lack of criteria for including the additional homes in the district and will ask the city's Historic Preservation Commission (HPC) to provide more information.

ed with a map that includes properties the HPC believes should be included the district.

Planning Board Chairman Bill Bezaire examined the list of properties and met with HPC Chairman Warren Coupland; Councilman Zack Mullock, who is council liaison to the HPC; and HPC Commissioner Dave Clemans.

A more complete list of properties suggested to be included will be available to the Planning Board At a previous Planning Board on a future date, Bezaire said. He

of affected properties.

Planning Board solicitor Richard King said while only 30 days of public notice is required before the Planning Board meets on the issue, the consensus he was getting was each property owner should receive notice by certified

Bezaire said the current list covers 95 percent of the properties. He said the map has specific

Board member Linda Wolfe said when Coupland first described the scope of the issue, it was fewer than 50 properties but has grown to 189. She suggested a notification process to affected property owners in stages, because the board could not handle in one meeting the appearance of potentially 189 residents. She suggested the work be divided into zones or sides of town.

Bezaire suggested a property owner against being in the district

could also file written notice with the board.

Deputy Mayor Patricia Hendricks said property owners may want to hear the rationale for why their home is being included. Bezaire suggested the HPC deal with the property owners.

"I don't think you can just start plucking out properties and start putting them in your historic district; you have to do this process,'

would obstruct lighthouse view

CAPE MAY POINT -No one wants to see a cell phone tower spoiling the view of the Cape May Lighthouse, least of all borough officials.

During a Nov. 26 work session, Borough Commission discussed an application for a cell pole in front of 213 Lighthouse Ave. Borough solicitor Brock

Russell said the commissioners had the ultimate authority to approve a ground-mounted cabinet for a new pole at a new location.

carrier were only replacing an existing pole with a new pole or installing an antenna on an existing pole or a cabinet on an existing pole, as long as they meet the specifications in the ordinance, it is reviewed by the borough engineer.

Borough Commission would then receive a letter from the borough engineer and have the job of approving a permit.

The Federal Communications Commission (FCC) approved an order last

year nationwide requiring a 90-day "shot clock" to approve or deny a new cell antenna site and just 60 days to approve attaching new 5G equipment to an existing pole. A municipality opens itself to a lawsuit if its approvals or denials exceed that time frame.

Russell said he did not believe the "shot clock" was suspended if a cell phone carrier's application were incomplete. For a new pole, the cell phone carrier must provide a survey of the location.

Commissioner Robert Mullock said he objected to the location because of He said if the cell phone the historic location of the lighthouse.
"I really feel that this

location is a terrible site, and that in fact, it would be actually better if this pole location was perhaps back where our generator is," he said. "If it has to be within a certain area at that location, then we have access on our driveway to allow them to access the

CAPE MAY — "It's alright to smile today," Capt. Sarah "Kathy" Felger, commanding officer of Coast Guard Training Center Cape May (TRACEN), told a gymnasium filled with recruits on Thanksgiving

The recruits sat bolt upright in bleachers and staring straight ahead while martial music played in the background, waiting for orders to form lines on the gym floor to meet a family ready to take them home for a Thanksgiving dinner. The American Red Cross organizes Operation Fireside to give recruits a holiday and a break from the arduous routine of basic

training TRAČEN and the American Red Cross placed more than 350 Coast Guard recruits with southern New Jersey families for Thanksgiving, according to spokeswoman Diane Concannon. She said 120 host families, as well as organizations such as Veterans of Foreign Wars, American Legion and Elks, signed up to bring recruits into their homes for the holiday.

"There was an outpouring of support and people stepping up to say they would like to host; we had a waiting list," she said. "We told folks, 'Next year, get in early."

Concannon said Operation Fireside has run for more than 35 years with a number of families hosting recruits every year.

"It's a tradition which is wonderful," she said.

The number of recruits at TRACEN varies year to year, Concannon said.
