The Washington Commons Condominium Association sought approval Oct. 21 for renovations to five buildings in the shopping complex.

Attorney Tony Monzo said the renovations include the Acme Market and adjacent stores.

He said there would be a resurfacing of the parking lot, replacement of light fixtures and some window replacements in building two, all "same for same."

Landscape architect/ professional planner Robert Shepanski said the complex is sided with cedar shakes done in the late

"Similar to what was done to Victorian Towers across the street, we're looking to modernize the shopping center with clapboard horizontal siding and some new trim details, where they are currently not present," he said.

Shepanski said the current siding wraps all the corners and goes tight to windows, producing an siding on all the buildings absence of corner and

Shepanski said trim would be added to all windows, doors and corners on the buildings.

The white border around the perimeter of the buildings would remain, he said. Shepanski said small, round columns on buildings two and three would be wrapped with a square column "to beef them up at bit.

Building two was the original building in the complex. It has singlepane windows that will be replaced. Buildings three, four and five have doublepane insulated glass, Shepanski said.

He said small awnings with about a 2-foot projection would be added over storefront entrances. Shepanski said architectural brackets would support

the awnings. The existing brick veneer would remain

on the buildings, he said. The Acme store currently has an overhang only over the entrance that measures about 12 feet by 12 feet, Shepanski said. Extending the overhang is still in development and not part of the current ap-

plication, he said.
"One of the worst things you can do for Washington Commons is not do anything at all," HPC Commissioner Jim Testa said. "So every idea expressed here makes to me very good sense.

He described the shop-ping center as "extremely tired."

Shade Tree Commission's oversight powers stronger

CAPE MAY — City Council approved an ordinance Oct. 15 strengthening the power of the city's Shade Tree Commission to govern the removal and preservation of trees.

Shade Tree Commission Chairman Jay Schatz said the legislation added a few items to an existing ordinance and gave the city's Shade Tree Commission "a little bit more strength in preventing clear-cutting of some of these lots when a house is torn down and when the floor area ratio changes, particularly east of Madison Avenue.

He said the commission could say approve or deny removal of a tree not within the footprint of a house, driveway or any outbuildings that are approved. Schatz said the ordinance allows the Shade Tree Commission to rule on a tree down to 6 inches in diameter, measured 4.5 feet above ground.

The ordinance also increases the fine for removing a healthy tree from \$25 to \$75 and it eliminates the limit on the number of trees that can be subject to a fine, he said. Formerly, the commission could issue fines only for as many as four trees on a property.

The state-mandated value of a tree is included in the ordinance, \$27 per basal inch for a tree that is damaged or removed with a
