of findings of leaks through exterior walls and windows. He said an architect and an assistant tested windows with a spray of water and found some infiltration.

Most of the water infiltration was seen coming through window sills and brick mortar in some locations, said Thornton at that time. He recommended starting with window sill repairs. When windows were sprayed on the second floor, the water made its way to the windows below bringing significant infiltration, said Thornton said in 2015.

'It appears the majority of the leaks are due possibly to the lack of flashing on the windows," he said. "That's something that we can't confirm.

At that time, Thornton said it would be a "costly endeavor" to replace all the effected windows, in the range of \$75,000 to \$100,000. He recommended taking out a window where a leak was seen and make it sure it was installed properly and if it solves the problem, proceeding with the remaining windows

Then-mayor Edward Mahaney asked to receive shop drawings and construction plans of windows replaced in City Hall from Remington Vernick since most of the windows in the building had been replaced.

At that time, Thornton recommended repointing of bricks in some areas. He said repointing mortar could cost \$75,000 to \$90,000 due in part to the historical designation of the building.

When repointing was undertaken earlier, the state **Historic Preservation Office** (SHPO) became involved concerning the texture and color of mortar to maintain the historic integrity of the building

In 2016, Thornton said it was his goal to have had some documents available

to receive quotes for an investigation of what may have contributed to the ongoing leaking of windows in City Hall. In a winter storm that year additional water infiltration was observed not just from the sills but also from lintels, structures across the tops of the windows, he said.

In 2017, the city's Public Safety Building Advisory Committee toured the police

station in City Hall. Police Chief Tony Marino said police headquarters experienced water intrusion on two sides of City Hall.

"We've lost computers, we've lost paperwork," he said at the time. "It has to do with the lintels above the windows that have been redone probably 10 times and for some reason they can never find where the water's intruding from.'
