# More historic design standards proposed

Preservationists want windows, solar panels, satellite dishes, turbines addressed

CAPE MAY — Additional items may be added to the city's Historic Preservation Design Standards to govern solar panels, wind turbines, satellite dishes and replacement

At an Oct. 4 City Council meeting, Mayor Edward Mahaney said the design standards first went into effect in 2003. He said Cape May's historic design standards became a prototype for other towns and are referred to by the state Historic

Preservation Office.

The mayor said technology, materials and tastes have changed and some issues have popped up that need to be addressed.

'I really believe that the design standards are the driving force behind maintaining our National Historic Landmark status," said Warren Coupland, chairman of the city's Historic Preservation Commission (HPC). "I believe it's also the critical document for maintaining the historic character of the city."

He said the Historic Preserva-

tion Design Standards have not effect on the streetscape, he said. been updated since 2002. While the design standards address windows, they need to be "tightened up" due to misunderstandings about wood replacement windows, Coupland said. He said the proposed addendums are in sync with guidelines from the Interior Department and the National Park Service.

Coupland said solar panels located on roofs are very visible. Roofs are generally a significant feature of historic buildings, and solar panels diminish the character of the building and have a detrimental

'Cape May is in a unique situation being a National Historic

Landmark in its entirety," he said. If solar panels can be hidden from a public thoroughfare on a flat or parapet roof, they may be acceptable, Coupland said. Three buildings in the city have solar panel installations, one of which is not visible to the public and two

Another installation is located at the very back of a property

that are barely visible, he said.

#### 6th annual event helps survivors of firefighters



CAPE MAY — At noon on Columbus Day, more than 50 people gathered on Steger's Beach for the 6th annual Memorial Paddle Out and Pasta Fundraiser in honor of Lt. Andy Boyt.

A former Cape May firefighter, Boyt passed away suddenly at the age of 45 in 2011. He joined the city's fire department in 1991, advancing through the ranks to lieutenant.

Friends and a number of lane May firefighters paddled out on surfboards into the chilly ocean to form a circle, say a prayer, splash the water and throw flowers in the air. Following the ocean ceremony, the public was invited to a pasta lunch at VFW Post 386 benefiting the National Fallen Firefighters Foundation.

Boyt's widow, Michelle, said the event remembered. honored and celebrated "someone who was so precious to the community." She said her husband was an avid surfer and the surf-

### Child porn sting nabs North Cape May man

CAPE MAY COURT partment, State Police ICAC HOUSE — Dennis Krueger, Unit, Homeland Security 45, of North Cape May, was arrested Sept. 30 for third-degree possession of child pornography, according to county Prosecutor Robert L. Taylor and Lower Township Police Department Chief William Mastriana.

The investigation stemmed from a Peer2Peer monitoring operation by members of the State Police and the county Prosecutor's Office's Internet Crimes Against Children Task Force (ICAC) for subjects that download and/or share illegal child pornography.

The operation revealed that an unknown subject downloaded several videos/ images of suspected child pornography via a Peer-2Peer network. The investigation resulted in a search warrant execution Sept. 30 at a residence in North Cape May by members of the county Prosecutor's Office, Lower Township Police De-

Unit, Homeland Security Investigations (HSI), and State Parole Board. During on-site forensic previews of the computers, multiple files of suspected child pornography were located. Several computers and cell phones in Krueger's residence were seized as evidence. Krueger was arrested and placed in the Cape May County jail in lieu of \$25,000 bail, pending

During the warrant execution, another resident at the same location, Ryan Krueger, 22, was charged with possession of drug paraphernalia, a disorderly person's offense, and released on a summons pending court.

Taylor stated that individuals charged with a thirddegree crime are subject to a term of imprisonment of three to five years in state prison and individuals charged with a disorderly persons offense can serve up to six months in jail.

### Twin sisters sworn in as city police officers

CAPE MAY — City Council welcomed two new fulltime police officers to the Cape May Police Department on Oct. 4, twin sisters Kara and Kourtney Brussell.

The sisters have worked for the department since 2013, when they graduated from the Class II Academy in Cape May County. They will attend the Basic Police Officer Academy in late January.

The Brussell sisters each completed the Cape May Police Department Field Training Program in September 2015 and since then have been working as squad officers on various shifts to substitute for full-time of-ficers. Once they graduate from the Basic Police Officer Academy, Cape May's police department will have three shifts with a female officer on duty, allowing the department to handle interactions
