Two charged with murder in teen's death

CAPE MAY COURT HOUSE — Two men were arrested Feb. 19 and charged with first-degree murder and first-degree murder during the course of a sexual assault in the December 2015 homicide of 15-year-old Nicole Angstadt.

Angstadt, a resident of the Erma section of Lower Township, was reported missing to Lower Township police by her mother Dec. 1. On Dec. 14, detectives from the Cape May County Prosecutor's Office and Lower Township Police Department went to Charles Mosley, 33, and a vacant property in the 100

Rio Grande where they discovered the teenager's body in the crawlspace.

"An exhaustive investigation conducted by members of the Cape May County Prosecutor's Office, Middle Township Police Department and Lower Township Police Department has led to the arrest ... with numerous offenses relating to the murder of Angstadt,

Robert Taylor said in a news release

According to Taylor, Powers was charged with first-degree murder, first-degree murder during the course of a sexual assault, conspiracy to commit murder, conspiracy to desecrate a human body, hindering apprehension, hindering apprehension of another, endangering the welfare of a

Judge John Porto set bail for Powers at \$1 million cash. In lieu of bail, Powers was being held at the Atlantic County

Lower will again seek MUA cash for budget

VILLAS — In a 3-2 vote that fell along party lines, Lower Township Council voted to request \$205,000 for the municipal budget from the Lower Township Municipal Utilities Authority for the second consecutive year.

Republicans Tom Conrad, David Perry and Erik Simonsen voted to request MUA funds while independents Mayor Michael Beck and Deputy Mayor Norris Clark cast negative votes.

In 2015, Lower Township approved a budget with a 1.9-cent increase per \$100 of assessed value in the local purpose tax rate, using a \$205,000 contribution from the MUA to pay the salaries of four new police officers expected to be hired that year.

At a Feb. 17 council meeting, Beck said he had consistently voted against taking money from the MUA, "especially this year because our budget contains a surplus that went up over \$1.2 million, which brought us for the budget year to \$5.2 million.'

He said his complaint was that not all of the township's taxpayers use water from the MUA.

"So taking money from the MUA, in essence, some people are paying the taxes of other people if you use it for the municipal budget,"

Climate control cost questioned

CAPE MAY — Volunteer fire-fighter Jim Matthews is questioning an estimate of \$180,000 to \$220,000 from the city's engineer to heat and cool the city's Fire Museum to preserve the fire department's 1928 American LaFrance firetruck.

"In my opinion, this report is very vague and his price ranges are outrageous," Matthews said.

He said the fire department was sending its 88-year-old pumper out to be refurbished to pristine

source and air conditioning source for this museum," he said.

During an October meeting with engineer Tom Thornton, of Hatch Mott MacDonald, and city officials, Matthews recommended ideas for heating and cooling the museum.

He said he recommended putting a wall across the hose tower and installing a door with a closer, install a new door on the outside of the hose tower with a closer, weather strip the front doors and install up in the museum's loft a wall-hung air conditioner.

"I told him we're not looking for

"We need to come up with a heat museum status, we're looking for approximately 40 to 50 degrees in the wintertime and 80 to 90 in the summer," Matthews said. "The money we're putting into this truck, we can't have 10 degrees in the win-

ter and 100 to 110 in the summer." The firetruck has been in Cape May since it was built, he said. "It's a very valuable tourist at-

traction to this town," Matthews He said he and others were in-

strumental in building the Fire Museum and keeping the antique

Attorney alleges Sheehan targeted

Captain's firearms tests not separated by 90 days in 2009

police department? Was the firearms officer afraid to report two senior officers failed to

qualify in firearms qualifications for fear of retaliation from within

the police department? These questions were asked during the first day of a disciplinary hearing held by the city for Capt. Robert Sheehan on Feb. 17, nearly one year after City Council voted not to renew his contract as police chief. At issue is that Sheehan qualified on the gun range in 2009 at the county police academy twice in that year but the qualifications were not separated by a three-month gap, thus disqualifying him from carrying a firearm by state attorney general guidelines.

Hearing Officer Richard Williams, a retired Superior Court-Appellate Division judge, explained the proceedings were not judicial but an administrative hearing on a disciplinary matter. He said he would render his decision in writing in 20 days from the conclusion of the hearing.

In his opening statement, Attorney Todd Gelfand, representing the city, said carrying a firearm without qualifying on the firing range with the 90-day gap was a third-degree criminal defense. He said the

Resident asks why Cape May not fixing beach slope

CAPE MAY — City resident Dennis DeSatnick said a lot of action has been taken by City Council in the past year for projects such as refurbishment of Lafayette Street and Rotary parks and extending the Promenade, but he was concerned the city's beach slope would not be addressed by summer.

At a Feb. 16 council meeting, he said he has spoken with City Council members regarding the beach slope that has been blamed for a number of injuries to bathers.

"Since September, I've been asking questions about the beach safety issue," DeSatnick said. "Many times it comes back, 'We've spoken to the Army Corps (of Engineers). We've spoken to the DEP (Department of En-

I'm hearing mostly is about the Promenade being extended."

"I have yet to this day to hear anything of what we're going to be doing for the summer to the beach," he continued. "I know we have a five-point program. I know we set up a committee. My concern is (summer) is three months away.'

DeSatnick asked if the city had a plan to address the beach slope.
