# Lower seeks outside opinion on service contracts

VILLAS — Lower Township Council voted unanimously to ask the New Jersey State League of Municipalities to recommend a consultant to look at the way the township awards professional service contracts.

At a Feb. 16 meeting, Deputy Mayor Norris Clark said there has been concern over the past year on how the township issues the contracts and how the township handles requests for proposals. He said council recently awarded one of the largest contracts in the history of the township.

In November, the engineering firm of Hatch Mott MacDonald was awarded a contract in a 3-2 vote of \$559,150 to design a project to provide for drainage and storm water improvements and road reconstruction to Roseanne Avenue and the Bayshore Estates area, an area plagued with flooding problems.

Clark said the awarding of the contract received a number of concerns and questions from the audience in clear terms and proposals

Clark said council put out a request for proposals for the contract and received no replies. A second request for proposals was offered. Beck complained council received quotes from three engineering firms only 30 minutes before the start of the council meeting.

Clark said the state comptroller in 2010 issued guidelines for municipalities issuing service contracts. The state guidelines state, "Historically the absence of rigid procedures frequently associated with the government's procurement of services has presented opportunity for abuse by unscrupulous public officials and government contractors.

State guidelines for contracting for services include the pool of contractors solicited should be as expansive as possible, statements of work should be presented

based criteria made known to vendors before proposals are submitted. In addition, the state recommends criteria should be judged by a qualified evaluation committee, the evaluation process should be explainable to evaluators and vendors and capable of withstanding scrutiny under a protest and the scoring process and award recommendations should be well documented and retained.

"I've asked the mayor to consider the prospect of doing a review of our approach and come up with recommendations for the township to make sure that we have a rhyme and a reason for the way we go about awarding our public service contracts," Clark said.

Beck said proposals for the Roseanne Avenue project were due by 11 a.m. Nov. 2, 2015, but he received the Hatch Mott MacDonald proposal at 7 p.m. at the start of the council meeting and had 33 pages of information to read. He said an average of the two lowest engineering bids for the Mott MacDonald's bid. Beck said if administration fees were averaged from the two other bids, it amounted to \$85,000 less.

"If this wasn't a township, if it was a private company and you pulled something like that, people would be fired," he said.

"We have a problem in our township with confidence in the procedure," continued Beck. "I personally believe that what we need to do is to get somebody from outside to come in and take a look at what we've done and every contract that we've handed out since I came on, for the past eight years.'

He said the outside consultant would then craft specific guidelines for issuing professional service contracts. Beck said he called the League of Municipalities, which has people who can assist the township on procedure for professional service contracts.

"All we're doing is going meeting to meeting and fighting and it needs to stop,"

Beck said.

During public comment, North Cape May resident John Skowronski asked Perry why he voted to request MUA funds. Skowronski said accepting the funding was unfair to MUA ratepayers that instead should receive a lower rate on their water and sewer

Perry said the MUA last year wanted to give the township more money than it needed for its budget.

'It was half-received last year and we're requesting to receive the other half this year," he said.

Villas resident Ed Butler asked Township Manager Jim Ridgway if the \$205,000 was needed "to pull the township out of a hole.'

"You must be if you're asking for somebody to donate something to you,' Butler said.

Ridgway said that one year ago, the township was close to a 3-cent tax rate increase and was "looking for help in a lot of areas." He said at that point the township talked to the MUA for help and some shared services between the township and MUA.

Ridgway said there was concern from some members of council last year the township's budget the following year would "be like a roller coaster" if the township accepted the MUA money.

'We thought 'Let's spread this over two years and grow the relationship between both parties,' and that's precisely what started," he said.

Public Works has worked with the MUA on several projects, shared vehicles and police on a road proj-


