not like no-bid contracts, the architect had been hired before he was elected, and \$135,000 had been authorized for architectural services.

What do we do now? Say there is no contract and maybe go to court? Or sign and go through the first stage? Do we discard the \$135,000 in architectural fees or reclaim the project and say

on the timeline?" he said. In response to another of Miller's questions, Mahaney said there was no commitment to use the city's engi-

neer, Remington-Vernick, to oversee the Convention Hall project. Miller said there was a conflict of interest between Remington-Vernick Kimmel Bogrette. Mahaney said Remington-Vernick was

interested in providing a "clerk of the works," to oversee the project, but the city had already informed the engineering firm it may or

may not go with them. "City council is looking at this project very, very carefully to come up with the best product at a reasonable cost. and at some point we need to have the trust of the community," Mahaney said. "I want the project to be a unifying force for the city - not a divisive one.

During the public hearing on Ordinance 160-2008, rescinding the old bond ordinance, Scott Maslow, Harry Bellangy and Jinny Hesel each commended city council for the action being taken. Hesel said she hoped the city would now "charge" the residents with coming out to the town meetings to make their feelings known.

On Monday, city council also passed Resolution 173-07-2008 authorizing the city to seek a meeting with the state Local Finance Board on Aug. 13 to discuss a new waiver for the down payment on the Convention Hall proj-

ect. Former mayor Jerry Inderwies and the city's auditor and chief financial officer had secured a waiver on the previous bond ordinance. which was rescinded. The waiver would not have carried over if the ordinance was rescinded or defeated by referendum.

this will not be an issue." Another issue addressed was the placement of handicap railings on the front ramp leading into the facility as well as the back stairs that lead down to the beach. These back stairs were removed because of mold. A new

design of a "spiral" staircase has been suggested as a replacement. The cost of this work is estimated between \$19,000 and \$20,000.

"We will have to give the designer some kind of design or sketch of what we believe to be suitable right through to construction to make sure that we meet building code requirements," Paul Martin said. "We don't think \$20,000 is going to cover all the building of this spiral staircase, but until we have designs

made, if that's the way you

(council) want to go this, then

we can start."

Besides cost, council was also informed that the type of rail system they wanted to use had to be considered as well. Materials for longevity and maintenance also had to be considered. When stainless steel railings were suggested, Deputy Mayor Linda Steenrod asked, "I'm not and engineer, but wouldn't stainless steel rails get hot in the summer?'

"Conceptually, yes", Martin answered.

"I would like to see that location be more handi-

capped accessible," Mayor Ed Mahaney said. "It may come down to cost, quality and longevity, especially when it's attached to other (existing) wooden railings. We don't want one to outlast the durability of the other."




