Cape May City Council rejects yard sale change, 3-2

CAPE MAY - Cape May City Council rejected any changes to the city's yard sale voting Ordinance 140-2008 by a 3-2 margin.

The ordinance was designed to allow two free weekends, Memorial Day and Labor Day weekends, when residents could have yard sales without obtaining a permit. Presently, residents are required

to obtain a permit costing \$2, and are limited to two yard sales per year. At the Feb. 6 meeting, Councilwoman

Steenrod on vacation, council seemed to agree to raise the fee to \$5 and establish two yard sale weekends, while allowing yard sales by permit throughout the year.

City manager Lou Corea had proposed the ordinance change to have two yard sale

> days each year to combat yard sale abuse. Some individuals, he said, have numerous yard sales by moving to different locations.

When Ordinance 140-2008 came up for introduction, Tuesday, it said residents could have yard sales on the Saturday and Sunday of both Memorial Day and Labor Day weekends without obtaining a permit, and on other days after obtaining a \$5 permit.

Mayor Jerry Inderwies said he had talked with "a lot of people" over the past couple of weeks, and his recommendation was to table the ordi-

"I recommend the ordinance be removed, tabled, and never brought up again,' he said.

Steenrod said she was opposed to "over-regulation" and didn't believe the yard sale policy needed to be adjusted.

'Maybe some closer enforcement," she said. Deputy Mayor Niels Favre said he was not one for government regulations, and felt the only change that needed to be made was to eliminate the yard sale ordinance. He said the \$2 fee for a yard sale permit doesn't cover the cost of processing the permit, so it should probably be done

away with. Councilman However. David Craig thought there was a need for licensing yard

"Otherwise you'll see couches on people's lawns every weekend," he said. "I thought maybe it could be free on the weekend of Memorial Day and Labor

Craig said the new ordinance allowed people two free weekends a year to have yard sales, plus another two per year by permit, and he thought that was a good idea.

Steenrod said she thought the matter needed some clarification, as she understood the ordinance to limit yard sales to Memorial Day and Labor Day weekends only.

Inderwies, Fayre and Steenrod voted against the ordinance change, Craig and Councilman Kurkowski voted in favor of the amendment.

As a result, there is no change in the yard sale ordinance, and property owners are limited to two yard sales per year, and must obtain a \$2 permit.

Former Lower basketball star arrested

LOWER TOWNSHIP Lower Township police arrested a former basketball star at Lower Cape May Regional High School, and one other man, and charged them with possession of a controlled dangerous substance with intent to distrib-

On Feb. 16, police were called to the Channel Apartments at 3910 Bayshore

Road, at around 1 a.m., on a report of a suspicious vehicle. Police arrived at the scene and located a Black Ford Explorer parked behind the E Building, with two males sitting inside. Police stopped the vehicle as it was leaving the

complex. Detective Ed Dougherty Patrolman Chad Fitzmaurice arrived and were talking to the passenger when they noticed a cigar on the ground next to the individual. The cigar had been hollowed out and filled with a green marijuana, what is commonly referred to as a "blunt." The officers also found green vegetation on the floor and in the side of the passenger side Police searched the vehicle

vegetation believed to be

and found 41 bags of suspected marijuana, or approximately 84 grams, a small zip lock bag containing 11 individual bags of white powder, and another zip lock bag containing several white hard rocks believed to be crack cocaine. Police also found \$500 in cash and a digital scale. Arrested was Charles

Johnson, 20, of Broad Street Court, Cape May. Johnson is a 2005 graduate of Lower Cape May Regional High School and was a 1,000-point career scorer in basketball, helping take his team to the state tournament.

Also arrested was Marcel Wright, 21, of Cape May Court House. Both men were lodged in the Cape May County Correctional Center on \$50,000 cash bail.
